# **DECADE - Warranty Statement.**

Decade Products, L.L.C. ("Decade") hereby warrants that the products listed below shall materially comply with the specifications provided by Decade for the applicable period. This warranty shall be voided by any repair, alteration, or modification to a product by any person other than an employee of Decade or its authorized representative, and by any abuse, misuse, or neglect of the products.

THE WARRANTY PROVIDED ABOVE IS A LIMITED WARRANTY AND IS THE ONLY WARRANTY MADE BY DECADE WITH RESPECT TO THE PRODUCTS OR ANY OTHER MATTER. DECADE EXPRESSLY DISCLAIMS, AND BUYER HEREBY EXPRESSLY WAIVES, ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ALL WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

Upon a breach of the limited warranty set forth in the first sentence of this paragraph (to the extent not voided by the terms of the second sentence), so long as buyer notifies Decade in writing of the breach within the applicable warranty period, Decade will at its option either repair or replace the products. Such repair or replacement shall be buyer's sole remedies for any failure of a product to meet the warranty specified above. If buyer fails to provide Decade with notice of the breach within the applicable warranty period, buyer shall not be entitled to any remedy for the breach.

WITHOUT LIMITATION TO THE FOREGOING, DECADE SHALL NOT (UNDER ANY CIRCUMSTANCES) BE LIABLE TO BUYER OR ANY THIRD PARTY FOR ANY SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES BASED UPON BREACH OF WARRANTY, BREACH OF CONTRACT, NEGLIGENCE, STRICT TORT, OR ANY OTHER LEGAL THEORY.

All products must be used per the product specification sheets to prevent voiding the warranty, which are available from Decade and should be carefully read before use.

## 1. RACX® Pallets

Pallets manufactured by Decade are warranted for a period of one (1) year for material and workmanship from the date of shipment to the purchaser and for one (1) year for all colorfast properties.

## 2. MACX® Containers

Containers (bins) manufactured by Decade are warranted for a period of one (1) year for material and workmanship from the date of shipment to the purchaser and for one (1) year for all colorfast properties.

For all **customized bins**, including any post molding work, the warranty period will be one (1) year for material and workmanship. In the event of a conflict regarding the warranty period, the one (1) year term shall control and supersede.

## 3. DOLAV® Plastic Products ("DOLAV")

All containers/bins and pallets manufactured by DOLAV are warranted for a period of one (1) year for material and workmanship from the date of shipment to the purchaser and for one (1) year for all colorfast properties.

#### 4. Lids & Other Accessories

Lids (covers) and all other accessories are warranted for a period of one (1) year for material and workmanship from date of shipment to the purchaser and for one (1) year for all colorfast properties.

## 5. USDA/FDA & EU Food Contact

Based on documentation received from our raw material suppliers, we hereby certify that all material used in the production of MACX® bins, RACX® pallets, and DOLAV bins and pallets in all colors (**EXCEPT BLACK**) are FDA/USDA approved for use in containing and transporting food products in compliance with the FOOD AND DRUG ADMINISTRATION's standards as set forth in TITLE 21 (parts 170-199) CFR 177.1630.
